# THE JURIED SHOW

Westman Region artists are invited to enter the 46<sup>th</sup> Annual Westman Juried Art Show. The purpose of the Juried Show is to provide amateur and emerging artists a venue for professional critique (all pieces receive a critique) and an opportunity to present their work to the general public. The opening ceremony will be held at 2:00 pm; doors open at 1:30 and close at 3:30 pm. The exhibition will be available for public viewing only at the public reception. All works, unless disqualified by the jurors will be displayed at the public reception.

#### **DELIVERY AND PICKUP OF WORKS**

Works may be delivered to MB Municipal Relations, Rm 335, 340 - 9<sup>th</sup> St, Brandon (Provincial Bldg) between **April 15 & 23 only** or between 10:00 and 10:30 a.m. at Reston RES Centre on Friday, April 25.

Note: works must be wrapped suitably for transport by car.

Artists are requested to make arrangements to pick up works not selected for the Travelling Gallery on Sunday, April 27 between 3:30 and 4:00 pm from Reston RES Centre.

# THE TRAVELLING GALLERY

The jurors will select 20 works for the Travelling Gallery which will tour communities in the Westman Region over the following year. Jurors' selection is final. Crates will be used for the transportation of the Gallery. All works will be insured from arrival at the Juried Show and the Travelling Gallery works for the year on tour. At the conclusion of the tour, the Arts West Council will arrange return of works to the artists.

### To be eligible for the Travelling Gallery:

- \*work must measure no more than 26" by 26", no less than 11" by 14", including frame.
- \*youth and adult work must be securely framed and wired

Work not meeting these size restrictions will be accepted for the Juried Show only.

# REGULATIONS

- 1. Artists must reside in the Westman Region and be at least 11 years of age as of December 31, 2024.
- 2. Prizes are restricted to Best in Show, Youth Awards, People's Choice, Theme Category Award.
- 3. Each artist may enter a maximum of two works, regardless of category.
- 4. Categories are: Painting-any medium; Fibre Art; Printmaking; Drawing-any medium; Silkscreen; Scratch Art, Mixed Media. All work to be two dimensional.
- 5. All works submitted to this Juried Show must be **original hand-made works of art**, completed within the past 12 months. Reference photos must be those of the artist; written permission for use of photos by other people must accompany the entry. Works that do not meet these criteria will be disqualified. (If written permission cannot be obtained, do not submit the work.)
- 6. All entries must comply with Arts West mandate on cultural integrity and cultural appropriation (view at <a href="https://www.artswestcouncil.ca">www.artswestcouncil.ca</a>).
- 7. Framing requirements: **Adults**-all works must be in a solid frame, ready for hanging (includes stretched canvas). Install sturdy hooks and wire on the back, approximately 3 inches below top of frame. **Youth-** framing not required, all works must be mounted (fixed to a firm support, ie-cardboard backmat).
- 8. Labels contained in this brochure are to be firmly attached to the backs of works.
- 9. All works are to remain on display until 3:30 pm. No exceptions will be made.
- 10. Artists whose works are selected for the Travelling Gallery must permit their works to remain displayed and toured for a period of one year.
